Qualifications/Exclusions

We will need access to the internal and external stop taps of the property. Where access through cupboards is necessary (e.g. in a kitchen), these must be cleared prior to our arrival.

Our price excludes any works not detailed specifically in the schedule of this quotation. This price assumes unobstructed, straightforward access to the property and pipe-work, or as seen and agreed during a pre-arranged site survey. If access is not straightforward or as previously agreed, or there are unforeseen delays whilst on site, additional costs may be applied.

Site abortive/ waiting time caused by other trades will be recorded and chargeable at the hourly rate of £52 net (an example being unable to access the property).

Commercial General

Quotation open for 30 days and subject to ALD terms and conditions (available on request).

We are unable to offer a credit account; payment is due on the date of our invoice following goods supplied or services provided.

We reserve the right to include an additional charge of 4% above bank base rate per month on overdue payments.

All prices (where not expressly stated) are subject to VAT, which will be chargeable at the prevailing rate.

Ownership and title of goods, intellectual property rights for any other supplied shall not pass to the buyer until ALD has received payment in full.

Any equipment supplied or services installed become the buyers to ensure and insure their protection and safekeeping.

Acceptance, confirmation and payment terms

Quotations are valid for 30 days from date stipulated of estimate/quote. After this time, all prices are subject to change.

Payment terms: Orders over £1500 (Exc. VAT): If estimate is to your satisfaction, A signed acceptance and purchase order will allow us to schedule development and production of your project. A deposit of 50% of the total is required upon placement of order, with balance of 50% plus extras due immediately on completion. If a deposit and acceptance are not received by the required date, ALD reserve the right to withdraw from this agreement. Variations and alterations to the contracted project will be quoted and charged as they arise.

Orders below £1500 (Exc. VAT): Once a quotation has been received, the client must provide written confirmation that such a quote is acceptable. The quotation will thus form the basis of the contract between ALD and the client.

Planning and production

Planning and production schedules will be developed in consultation with you as per project requirements.

Should projects require works outside of standard working hours (prior to 0600 hrs or after 2000 hrs) and additional early or late access fee will be charged. This fee is calculated at a rate of £ 45 per man per hour. This charge is calculated on the hours worked outside standard working hours.

Any additional requirement necessary for completion of work, not detailed within, will be charged accordingly and will be included in the final invoice.

Charges

We reserve the right to add finance charges on outstanding balances overdue after 30 days from the date of invoice. Charges will be made at the rate of 4% above the bank base rate per month
